Page 52.	Q: If you are planning to host this solution in a data center environment, you can take off server rack plus L2 switch cluster to reduce cost. Since you have a requirement for a server rack also, would you mind go for that option?
	C: we are planning to implement this architecture in our infrastructure and L2 switch cluster cater only our requirements, we don't need to share our activities with other devices in data center since the security matters. Sri Lanka CERT planning to get data center co-location services separately.
